1. The licensee agrees to pay all charges (including without limitation dockage charges, utility charges, etc.) in advance on a credit card deemed acceptable by the Marina at its sole discretion. 2. **This Licensee Agreement is an addendum to the marina dockage license agreement.** The licensee acknowledges that he or she has read and agreed to the terms and conditions of the Marina Dockage License Agreement posted and provided at the Marina Office at 28 Constitution Road, Boston, Massachusetts and agrees to comply with all provisions of the Marina Dockage License Agreement
3. The period of the guest license is restricted to the number of nights or weeks set forth herein this document. The charges are as set forth in this document, the license is not renewable (any extension is at the Marina's sole discretion.). If this conflicts in any way with the Marina Dockage License Agreement, then the terms of this Guest Agreement shall supersede; in all other respects the terms of both agreements shall apply.
4. Rafting may be necessary at the discretion of the Dockmaster.
5. A \$4 per key return fee will be charged for any marina keys not returned upon departure
