**CONSTITUTION MARINA 2011/2012 SEASONAL DOCKAGE AGREEMENT**  
***for returning customers***

All terms and conditions of the Dockage License Agreement with current revisions on file with Bosport Docking LLC remain in full force and effect. **Current insurance certificate naming Bosport Docking LLC as an additional insured must be on file.**

**WINTER SEASON (NOVEMBER 1, 2011 - APRIL 15, 2012) (AFTER MAY 1<sup>st</sup> guest dockage rates charged to cc)**

- A. **Wet Storage \$44/ft - electric metered and charged monthly to cc**.....\$44 x \_\_\_\_\_ (LOA) = \$ \_\_\_\_\_

*Winter only licenses are due in full at signing (haul, powerwash/relaunch at \$19/ft will be billed separately)*  
*Only boats with trailers can be hauled for winter storage. There will be no boats on stands in inside storage.*

**SUMMER SEASON (MAY 1, 2012 - OCTOBER 15, 2012) DOCKAGE FEES ARE BASED ON OVERALL**
